To qualify for a Real Estate Broker license, you are required to complete eight courses and pass the state Broker licensing exam. Required courses include Legal Aspects of Real Estate, Real Estate Appraisal, Real Estate Economics, Real Estate Finance, and Real Estate Practice. The remainder of the courses (shown right) are electives approved by the Department of Real Estate.

**Eligibility requirements for Broker license applicants in California:**

- Applicants must be 18 years of age or older and a legal resident of the United States
- Applicants must show themselves to be honest and truthful
- Applicants must have successfully completed eight courses
- Effective January 1, 2013, applicants must have at least two years of licensure as a full-time real estate salesperson during the five years immediately preceding the date of your broker examination application or obtained a bachelor's degree from a four-year college with a major or minor in real estate

## requirements

### Salesperson First Renewal

Salespersons renewing their license for the first time are required to complete a 45-hour first renewal, consisting of:

- Five separate 3-hour subjects in Ethics, Agency, Trust Fund Handling, Fair Housing, and Risk Management
- 18 hours of consumer protection
- 12 hours of either consumer service or consumer protection

### Broker First Renewal

Brokers renewing their license for the first time are required to complete a 45-hour first renewal, consisting of:

- Six separate 3-hour subjects in Ethics, Agency, Trust Fund Handling, Fair Housing, Risk Management, and Management & Supervision
- 18 hours consisting of consumer protection; the remaining hours must consist of either consumer service or consumer protection

# SECOND AND SUBSEQUENT RENEWAL

## requirements

### Salesperson & Broker Second and Subsequent Renewals

For subsequent renewals, Salespersons and Brokers are required to complete 45 hours of approved education, consisting of:

- 18 hours in Ethics, Agency, Trust Fund Handling, Fair Housing, Risk Management, and Management & Supervision
- OR
- An 8-hour survey course that covers all of the six subjects listed at the left

AND

- 18 hours consisting of consumer protection
- The remaining hours must consist of either consumer service or consumer protection
